

Terms & Conditions
“Up In The Air” – EVENT/GU/BCC + Village Promotion

1. Information on how to enter forms part of these conditions of entry.
2. Entry is open to Australian residents of NSW, ACT, VIC, QLD, NT, SA, TAS and WA who are current CINE BUZZ members and forward their Member Get member offer email to a non-member OR non-members who join the CINE BUZZ club in response to the Member Get member promotion OR a current Village Movie Club member who scans their VMC card when purchasing their tickets at the Ticket Box or purchase their tickets online to ‘Up In The Air’ during the competition dates to automatically go into the draw to win.
